

## QUOTES FROM YOUR CONSTITUENTS ABOUT ENERGY CHOICE

In Massachusetts, almost half a million customers shop in the retail energy market and choose an energy supplier other than their utility. Customers cite price, unique contract terms like flat monthly billing, certainty of pricing with long-term contracts, higher renewable energy content and value-added plans like free nighttime charging for EVs and home energy use management products as the reasons they choose to enroll with a retail energy provider.

**More than 3,000 Massachusetts residents have spoken out against proposed legislation (H. 3196 and S. 2106) to close the residential retail energy market**, asking their elected officials to protect their ability to shop and choose their energy supplier. Their names and quotes are listed below.
